On March 6, 2014, the Town of Barre, Town of Belchertown, Town of Brookfield, Town of Charlemont, Town of East Brookfield, Town of Goshen, Town of Granby, Town of Great Barrington, Town of Heath, Town of Mendon, Town of New Braintree, Town of North Brookfield, City of Northampton, Town of Rowe, Town of Upton, Town of Warwick, Town of Wendell, Town of West Brookfield, Town of Williamsburg, Town of Hampden, Town of

Chesterfield, Town of Conway, Town of Cummington, Town of Deerfield, Town of Gill, Town of Hadley, Town of Hatfield, Town of Huntington, Town of Leverett, Town of Middlefield, Town of Montague, Town of Northfield, Town of Pelham, Town of Plainfield, Town of Westhampton, and Town of Whately (collectively, the "Municipalities") each filed with the Department of Public Utilities ("Department") a petition seeking approval of a municipal aggregation plan ("Plan"). The Department docketed these petitions as D.P.U. 14-10, D.P.U. 14-11, D.P.U. 14-12, D.P.U. 14-13, D.P.U. 14-30, D.P.U. 14-31, D.P.U. 14-32, D.P.U. 14-33, D.P.U. 14-14, D.P.U. 14-35, D.P.U. 14-15, D.P.U. 14-16, D.P.U. 14-17, D.P.U. 14-36, D.P.U. 14-29, D.P.U. 14-37, D.P.U. 14-18, D.P.U. 14-38, D.P.U. 14-39, D.P.U. 14-19, D.P.U. 14-40, D.P.U. 14-41, D.P.U. 14-20, D.P.U. 14-21, D.P.U. 14-22, D.P.U. 14-42, D.P.U. 14-43, D.P.U. 14-44, D.P.U. 14-23, D.P.U. 14-24, D.P.U. 14-25, D.P.U. 14-26, D.P.U. 14-27, D.P.U. 14-46, D.P.U. 14-47, and D.P.U. 14-28, respectively.

General Laws c. 164, § 134 authorizes a municipality to procure a contract for electric supply on behalf of electricity consumers within its municipal borders. Eligible consumers not already enrolled with an alternative electric supplier will be automatically enrolled in the municipal aggregation program unless they chose to "opt-out" in which case they would remain enrolled on basic service provided by their electric distribution company (<u>i.e.</u>, Western Massachusetts Electric Company or Massachusetts Electric Company d/b/a National Grid, depending on the customer's location).

To implement each aggregation program, the Municipalities each seek Department approval of their respective Plans. The Municipalities' filings include a form competitive electric service agreement, which will be negotiated with potential electrical supplier(s). The Municipalities have retained the Hampshire Council of Governments to serve as its agent in this proceeding. Under the Plans, the Hampshire Council of Governments will assist in the implementation of the municipal aggregation programs and may serve as the competitive supplier. The Municipalities seek a waiver, on behalf of its competitive supplier, of certain information disclosure requirements contained in G.L. c. 164, § 1F(6) and 220 C.M.R. § 11.06(4)(c).

The Department will conduct a public hearing for all of the Plans at the City of Northamption's Municipal Building, Council Chambers, located at 212 Main Street, Northampton, Massachusetts 01060, on **Tuesday, April 15, 2014, at 6:00 p.m.**, to receive comments on the Municipalities' petitions. Any person who desires to comment may do so at the public hearing noted above or submit written comments to the Department no later than the close of business (5:00 p.m.) on **Tuesday, April 15, 2014**.

Any person wishing to participate in this proceeding must file a written petition for leave to intervene with the Department not later than the close of business (5:00 p.m.) on **Monday**, **April 7, 2014**. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 C.M.R. § 1.03. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 C.M.R. § 1.01(4). To be allowed,

a petition under 220 C.M.R. § 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10.

An original of all written comments or petitions to intervene must be filed with Mark D. Three copies of all written comments and petitions to intervene must also be sent to Jonathan Goldberg, Hearing Officer, at the Department of Public Utilities.
